The Center for Medicare & Medicaid Services (CMS) has just announced that it is suspending enforcement of the HIPAA Health Plan ID requirements, number (HPID) effective immediately, until further notice. This is not a Halloween Trick or Treat joke, however, we are certain that it will be greeted with euphoria for those who have been trying to get an HPID before the November 5, 2014 deadline. website portal has been less than desirable to work with and there is an 89 page User Manual of instructions for a 1 page form. Effective October 31, 2014, the Centers for Medicare & Medicaid Services (CMS) Office of e-Health Standards and Services (OESS), the division of the Department of Health & Human Services (HHS) that is responsible enforcement of compliance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA) standard transactions, code sets, unique identifiers and operating rules, announces a delay, until further notice, in enforcement of 45 CFR 162, Subpart E, the regulations pertaining to health plan enumeration and use of the Health Plan Identifier (HPID) in HIPAA transactions adopted in the HPID final rule (CMS-0040-F).

This enforcement delay applies to all HIPAA covered entities, including healthcare providers, health plans, and healthcare clearinghouses. On September 23, 2014, the National Committee on Vital and Health Statistics (NCVHS), an advisory body to HHS, recommended that HHS rectify in rule making that all covered plans, entities (health healthcare providers and clearinghouses, and their business associates) not use the HPID in the HIPAA transactions (see http://ncvhs.us/wp-

content/uploads/2014/10/140923lt5.pdf).

This enforcement discretion will allow HHS to review the NCVHS's
